## Magna Carta

Charter of Freedoms. Sealed in perpetuity 15<sup>th</sup> June 1215. ALL 63 clauses are valid.

## **Local Government Act 1972**

**Section 2 Paragraphs 1 – 2 – 3 (3 in particular)**

Constitution of principal councils in England.

**(1)** For every [F1non-metropolitan] county there shall be a council consisting of a chairman and councillors and the council shall have all such functions as are vested in them by this Act or otherwise.

**(2)** For every district there shall be a council consisting of a chairman and councillors and the council shall have all such functions as are vested in them by this Act or otherwise.

[F2(2A) Where a council mentioned in subsection (1) or (2) above are operating executive arrangements which involve a mayor and cabinet executive F3..., the council shall consist of an elected mayor, a chairman and councillors.]

[F4(2B) In such a case, a reference in this Act to a member of a council is a reference to—

- (a) the elected mayor of the council,
- (b) the chairman of the council, or
- (c) a councillor of the council.]

**(3)** Each council mentioned in subsection (1) or (2) above **shall be a body corporate by the name “The County Council” or “The District Council”**, as the case may be, with the addition of the name of the particular county or district.

This act made **ALL** councils **corporations**. **Therefore Council Tax is FRAUD.**

**The Werner Report** 1968/70 written by the then prime minister of Luxembourg was hidden because it shows that to join the EEC was **TREASON**.

**Administration of Justice Act 1973 - REMOVED the Queens sovereignty. This makes the Monarch just the head of the CORPORATION.**

**Edward Heath committed TREASON 1972/73 by signing the UK into the EEC.**

**Therefore after January 1<sup>st</sup> 1973 ALL ACTS & STATUTES ARE VOID.**

The councils beloved legislation **Local Government Finance Act 1992 is after 1973, therefore is void.**

Council tax is paid into the **Government consolidation fund, NOT** to local councils. The council are then given some back with conditions on how it must be used.

### **Our Government - Charged With the Below Crimes:**

**Treason** - To hand over the sovereignty, the decision-making ability of the nation to a foreign entity, without first being beaten in open battle or by the expressed consent of the people.

**Sedition** - To publicly write or speak with the intention of inciting the destruction of the constitution.

**Misprision** - Misprision (of treason) is to know of an act of treason being planned or committed within or without the realm, and not to report the crime to a justice of the peace. Then you are also guilty of the crime, or an accessory to it.
